EXTENSION OF TMV AND DMT TERMINALS



On 15 November 2012 Christine Cabau Woehrel, Chair of Dunkerque-Port's Executive Committee, and Philippe Bertonèche, Chair of the Development Board, opened the extension of the «Multivracs» Bulk Terminal (TMV) and Dunkerque Multibulk Terminal (DMT).

To improve traffic handling capacities for «small» solid bulks. Dunkerque-Port decided to extend the storage areas of the TMV and enlarge its quay. The first studies were begun in 2008 and work started at the end of March 2010. The project consisted in extending the existing quay over a length of 280 metres to the east and creating a new storage yard of 3.5 hectares. The works were completed during the summer of 2012. The operation, costing a total of €13.1 million, will allow the handling of an additional 900,000 tonnes a year. As regards the DMT quay, the project for reconstruction and creation of a storage yard followed structural problems encountered during operation. To provide the operator with a fully operational infrastructure, Dunkerque-Port decided to demolish the existing, dilapidated wharf and reconstruct a quay (200 m long, with a draught of 14 m) offering a storage yard of 1.5 ha and new accessways. The works were completed during the summer of 2012. The operation, costing a total of €12.1 million, will provide reception and storage facilities for all types of bulk goods, near the multi-purpose Silonor shed to the rear of the storage yard. Dunkerque-Port expects these new capacities to reinforce its position in the solid bulks sector and allow continued diversification and growth in its historic traffic lines
